The following changes to NEMT will be effective immediately, in response to the declaration by Governor Hogan on January 4, 2022 of a State of Emergency and Catastrophic Health Emergency.

Effective Immediately Maryland Medicaid NEMT will adapt the current after hours operations procedures for <u>all</u> Hospital Discharges from In-patient Acute Care Hospitals and Emergency Departments. This means this policy will apply during normal business hours as well.

- Non-Emergency Medicaid Transportation (NEMT) is provided under contract between the 24 Maryland jurisdictions and specific vendors. Not all Medicaid enrolled transportation vendors are eligible to provide services under this program. Only providers on the attached list are approved for use under this memo for the transport of Maryland Medicaid participants for discharges or transfer to a tertiary care center for a higher level of care.
- Hospitals will contact transportation vendor(s) directly irrespective of the jurisdiction listed with whom they have a contract - from the attached list, to schedule the clinically appropriate level of NEMT services. Ambulance transportation must be clinically indicated for at minimum a BLS level of care <u>during</u> transport.
- The transportation provider will be responsible for obtaining the following documentation from the requesting facility:

- a. Statewide Provider Certification Form (PCF) Attesting to the clinically appropriate mode of transportation.
- b. Patient Demographics (face sheet)
- c. EVS Documentation (copy of the confirmation screen completed online, or with the confirmation number if verified by phone)
- The transportation vendor will be responsible to ensure that:
 - a. The requested level of transportation is clinically appropriate based on NEMT guidelines.
 - b. The PCF is complete and signed by the correct provider; and
 - c. The EVS is utilized (telephonic or web based) to ensure participant eligibility. For telephone verification, the vendor must provide the confirmation number or a copy of the web-based verification form.
- The Transportation Grant Manager must be notified on the first business day after the transportation has occurred and receive copies of the Statewide PCF, Demographics sheet, EVS verification, and the run sheet.
- The trip will be reviewed by the Grant Manager and a final determination of payment to the transportation vendor will be made based on the above information provided.

This policy will remain in effect until such time that the Governor of Maryland declares an end to the State of Emergency and Catastrophic Health Emergency.
